#### **Enactment of Investment Law No. 4 of 2006**

#### Reasons Requiring the Law

This law was promulgated to: create a climate that promotes investment in the Kurdistan Region-Iraq; remove legal obstacles; open the way for investment of national and foreign capital jointly or separately in projects that contribute effectively to the economic development process; grant facilities, promotional incentives, and tax exemptions for invested capital; and create a specialized Board of Investment to regulate the various aspects of investment operations in the region.

#### **Board of Investment**


The Board of Investment is an independent legal person that provides for a favorable climate for investment and is responsible for regulating and developing investment in the Kurdistan Region-Iraq.

The Board has issued this guide to serve as a reference for investment in the Region by domestic and foreign investors. This guide includes a summary of the investment environment in the Region according to the various economic sectors. It also clarifies the means for taking advantage of Investment Law No. 4 of 2006.

The Kurdistan Region-Iraq is distinguished by its plentiful natural resources, including minerals, oil, and water resources, fertile land, and specialized, competent human resources. The Kurdistan Region enjoys a climate suited to agriculture, depending on the various seasons.

The Government of the Kurdistan Region [continues] to play a vital role in achieving national unity in Federal Iraq and in firmly establishing the principles of democracy and the rule of law. It works to provide and guarantee all facilities required by investors for development and economic advancement.

#### Vision

The Board of Investment in the Kurdistan Region, in cooperation with the relevant government agencies and institutions, encourages domestic and foreign investment to achieve development and economic growth.

#### **Objective**

Action to create investment opportunities and a favorable investment climate, and to rebuild Iraq, starting with the Kurdistan Region.

# Basic Information on the Kurdistan Region

Area: The area of the Region totals

80,000 square kilometers, i.e., 18 percent of the area of Iraq.

# Population and Population Distribution:

The population of the Region totals about 4,095,443, of whom 70 percent live in urban areas, with the rest living in rural areas.





#### **Topography of the Region:**

The Region is characterized by varying topography, including mountains, hills, plains, valleys, and water sources, all of which provide a favorable climate for investment, especially in the agriculture and tourism sectors.

#### **Natural Resources of the Region:**

- The Region features diverse water resources, e.g., rivers, lakes, groundwater, springs, and rainwater.
- It features large forested areas, most of which cover the slopes of the Region's mountains.
- The Region also enjoys enormous livestock wealth.
- The Region is enormously rich in



petroleum resources, such as natural gas, and bituminous coal, as well as iron and copper ore.

#### **Climate of the Kurdistan Region**

The climate of the Region is characterized by cold winters. The mountainous areas where snow falls become icebound in the winter. The Region is pleasant in the spring and autumn and dry and hot in the summer.

Rainfall in the Region varies. The average annual rainfall ranges from 328 mm in Khanaqin to more than 702 mm in Zakho, 969 mm in Rawanduz, 1008 mm in Akra, and 1263 mm in Penjwin. These rainfall amounts indicate that rainfall increases as one moves toward the north and northeast as a result of the higher elevations. The Region can be divided into two basic areas with respect to rainfall:

Regions with certain rainfall: They

include the northern and northeastern areas of the Kurdistan Region-Iraq and the southern boundary parallel to the mountainous areas, where average [annual] rainfall is not less than 500 mm. Thus, agriculture in such areas depends entirely on rainfall.

• Areas with uncertain rainfall: They include semi-mountainous areas where [annual] rainfall does not exceed 500 mm. These areas have light rainfall compared to other areas and are generally subject to drought.

# Governorates of the Kurdistan Region

#### **Governorate of Erbil:**

Its center is the historical city of Erbil, the capital of the Region. It is bounded by broad plains and several hills to the east. The population in the governorate is 1,431,580. Kurds comprise 93 percent of the population, which also includes Turkomans, Chaldeans, Assyrians, and Syriacs.

The city of Erbil is famous for the archaeological remains of its fortress, whose history goes back beyond 6000 years BCE, and whose area totals 14,471 [square] kilometers. UNESCO considers the fortress, which remains inhabited



to this day, one of the most important archaeological sites in the world.

The climate of the governorate is dry and hot in the summer and cold and rainy in the winter. Spring is enchanting. Agriculture and the raising of livestock are the main economic activities in the governorate. Many industries, trades, and factories are spread throughout the governorate. Tourism activity has become brisk in the governorate due to the security and stability that has prevailed in the Region in general.

### Governorate of al-Sulaymaniyah: The governorate of al-Sulaymaniyah



is one of the main cities in Iraq. It was founded in the second half of the eighth century. It is linked to the east with the Iranian border. The population of the governorate is estimated at about 1,704,740, 78 percent of whom live in urban centers.

The governorate is distinguished by its natural beauty, consisting of mountains, dense forests, springs, streams, and artificial lakes, such as Dokan Dam Lake and Darbandikhan Dam Lake, all of which has made the governorate a tourism magnet for summer vacationers from other parts of Iraq and abroad.

#### Governorate of Duhok:

The center of the governorate is the city of Duhok, which was built in 1887 during the Ottoman Caliphate. It is



located in the extreme northwest of Iraq. Its area totals about 10,715 square kilometers, and it is 583 meters

above sea level.

Duhok is a governorate of special importance because of its history. Antiquities and sculptures have been discovered in its hills and caves. It is also characterized by a varied topography of towering, extremely rugged mountains. Mountains bound the city from all sides, giving it an enchanting appearance. A small river originating behind the large Duhok Dam descends from it. The water from the river is used for agricultural purposes and is the main drinking water source. Duhok has become one of the most beautiful tourism regions. The governorate has many health resorts at Zawita, Swara Tuka, Sarsank, Sulaf, Ashawa, Anishki, and elsewhere. The city of Duhok is famous for its many orchards and vineyards. It is even called the City of Vineyards. Development has expanded on the southern, western, and eastern sides of the city.

#### Areas of Investment in the Region

- 1. Manufacturing industries, electricity, and related services.
- 2. Agriculture, raising of livestock, forestry, and related services.
- 3. Hotels, tourism and recreation projects, and amusement parks,



- 4. Health and environment.
- 5. Scientific research, technology, and information technology.
- 6. Transportation and modern telecommunications.
- 7. Banks, insurance companies, and other financial institutions.
- 8. Infrastructure projects, including construction, housing, roads, bridges, railroads, airports, and irrigation and dam projects.
- Free zones, modern commercial markets, and related consulting services.
- 10. Education at all levels in the framework of the Region's educational policy.
- 11. Any project in any other sector, as decided by the Supreme Council for Investment.

#### **Treatment of Foreign Investors**

- 1. Foreign investors and foreign capital are treated as national investors and national capital.
- 2. A foreign investor who establishes a project in the Region is entitled to own the entire project.
- 3. A foreign investor may transfer the profits of a project and interest on his capital abroad according to the provisions of the Investment Law.
- 4. A foreign investor is entitled to repatriate his capital upon the liquidation or disposal of the project, provided doing so does not conflict with the provisions of law, customs procedures, and tax procedures.
- 5. A foreign investor is entitled to insure his project through any national or foreign insurance company.

# Facilities, Exemptions, and Privileges Contained in the Investment Law

- 1. Exemption of projects from all taxes and non-customs duties for a period of 10 years.
- 2. Exemption from taxes and duties for machinery, implements, equipment, vehicles, and machines imported for a project, provided an import license is obtained.



- 3. Exemption from taxes and duties of spare parts imported for a project.
- 4. Exemption from customs duties of raw materials imported for production in a project for a period of five years.

#### **Additional Exemptions**

The Board grants additional incentives and facilities for the following investment projects:

- 1. Projects established in areas of the Region with the least growth.
- 2. Joint projects between a national investor and a foreign investor.
- 3. Investments in service projects, particularly hotels, hospitals, tourism villages, universities, and schools.

#### Facilities:

1. An investor may insure his investment project with any foreign or national insurance company that he deems appropriate.

- 2. An investor may employ domestic and foreign manpower.
- 3. Non-Iraqi employees may transfer their entitlements and wages abroad.
- 4. An investor may transfer all or a part of his investment to another foreign investor or to a national investor, or he may assign the project to his partner with the Board's approval after the project is completed.
- 5. An investor may open bank accounts for his project with national or foreign banks. The accounts may be in Iraqi dinars and/or foreign currency.
- 6. The Board must maintain the confidentiality of the technical and economic information pertaining to a project.

#### Investment License:

- 1. In applying paragraph 1 of Article 16 of Section 1, Chapter 4 of Investment Law No. 4 of 2006, the following shall be observed:
- 2. The investment activity of the project for which an establishment license is requested from the Board must be included in the economic sectors specified in Article 2, Section 2, Chapter 1 of the law.

- 3. A final legal judgment must not have been issued against the investor and/ or project on account of a material violation of the Investment Law and the provisions of these instructions.
- 4. The investor, whether a natural or legal person, must not have been convicted in the past of a financial or commercial violation in the Region, in Iraq, or in any other country.
- 5. It shall not be permitted to grant a license, concession, or exemption that results in the violation of any treaty or international or regional agreement to which the Region or Iraq is a party.

# Procedures for Granting a License to Establish an Investment Project:

The Board shall prepare an information guide for the investor that includes a description of: the procedures for obtaining a license to establish a project and for obtaining other permits and licenses required; the forms and documents that must be submitted; and any other essential information



required by the investor. The guide must include a presentation of the incentives, benefits, exemptions, and guarantees enjoyed by projects covered by the guide.

Investment applications must be submitted to the Board's main office or one of its branches in the governorates on the form prepared for this purpose. Full data must be provided on the application form, which must be submitted with all required documents indicated on the form. Applications must be signed by investors or their authorized representatives according to regulations. Investors may submit applications to the Board by direct delivery, mail, or fax or electronically. If the Board approves an establishment license, it may issue the license only after it receives original documents in cases where such documents are required. Within three days of receiving an application, the Board must convey, to the investor who submits the application, a written or electronic receipt bearing the application registration number and date.

Applications submitted to the Board must be examined according to the provisions of the Investment Law, instructions issued pursuant thereto, and decisions issued by the Supreme

Council or the Council of the Board.
A license to establish a project must be issued with the signature of the chairman of the Board or whomever he authorizes within 30 days of the date of fulfillment of the technical, legal, and economic requirements and conditions. Holidays and official breaks are not counted within the aforesaid period.

The Board must convey to the investment applicant the final decision issued regarding his application in writing by direct delivery, registered mail, electronic mail, or by any other means through which notification is made.

The concerned ministries and government departments in the Region must facilitate the immediate issuance of all necessary documents concerning matters relating to foreign investors and foreign workers, such as entry stamps, departure stamps, and residency documents.

Technical supervision and follow-up committees are to be formed in the concerned ministries in coordination with the Board to supervise, conduct field monitoring of, and ascertain the progress of the implementation of projects according to contracts and licenses granted to investors.

### The distribution of areas in the Kurdistan Region according to economic growth level is as follows:

- 1. Developing areas Category A: They include the boundaries of the municipalities of the cities of Hawler (Erbil) Sulaymaniyah, Duhok, and Zakhu.
- 2. Medium-growth areas Category B: They include the districts of the city of Soran, Shaqlawa, Hareer, Kawiya, Raniyah, Chamchamal, Kalar, Amedy (Amadiya), and Akir (Aqra).
- 3. Low-growth areas Category C:
  All subdistricts, areas, and villages
  [qasabat] in the Region not included in
  Categories A and B above.

The investor must provide the following for the investment project:

#### 1. Components of the project, including:

- •Original architectural drawing printed on A3 paper and designed by an engineering firm or licensed engineers.
- Site plan for the project.
- Estimated capital, or estimated cost.
- Period of implementation.
- · Construction method.
- · Amount of water and electricity units consumed.
- Amount of labor [required] during and after implementation of the project.
- 2. Economic feasibility study.
- 3. Environmental Impact Assessment (EIA).
- 4. After suitable land has been allocated for the project, the investor must prepare:
  - A topographical survey map of the land; and
  - A photocopy of the registration and demarcation of the boundaries.

#### For the Board of Investment

- 1. Administrative structure.
- 2. Activities in previous years.
- 3. Future investment priorities according to the Board's vision.



# Some of the Tourist Areas in Kurdistan

#### 1. Duhok Governorate

Zawita: This summer resort is 16 km from Duhok city, it rises 885 m above sealevel and the maximum temperature in summer is 38 C°. This summer resort is characterized by its temperate climate and availability of vast areas of shadows in the forests of high pine trees for which the area is famous. The resort is full of many rest areas/houses, casinos, restaurants and private kiosks that spread on both sides of the road to Swarah Toka and Sarsang, all of which provide accommodations for summer visitors in addition to the existence of some parks that scatter inside the city and its outskirts.



<u>SwarahToka</u>: This resort is characterized by the beauty of its location overlooking a ravine in an area surrounded by mountains from both sides. It also overlooks two plains on the sides of

Swarah Toka mountain chain, one of which is Bamarni Plain and the second

Swarah Toka Plain which provides the area with nice weather and pleasant air. The area is abundant with cypress trees and various kinds of mountain fruit. Thus, the weather of Swara Toka is similar to that of the most beautiful resorts in Kurdistan.

Gali Balanda: It is a mountain strait characterized by extreme complexity and ruggedness with gorges of difficult routes penetrating Matin mountain chain from one side and Mount Shireen from the other. The area rises about 3000m above sea level at the northeastern part of Duhok Governorate. These are newly formed flexuous with mountains intense natural vegetation cover which is mostly in the form of natural forests and bushes. It overlooks a ravine through which the river Roy Shen runs. The most important products are walnuts, green seed, almonds and various kinds of mountain fruits.

Backerman Resort: It is a large valley located along the chain of Mount Aqra, locally known as Mount Backerman, through which runs a large river formed by the confluence of Khazer and Comel tributaries. Its water flows amidst the

casinos, restaurants and private kiosks located near the resort. The river is surrounded by natural forest trees such as willows, hawthorn, gall oak, green plum, green seed, oak oleander, orchards and fruit varieties. Throngs of tourists arrive in the area from inside and outside the Governorate during summer to spend time of rest and recuperation.

Sharansh: the resort is famous for its marvelous waterfall whose water flows from the high mountains of Zquirah and Khabour, the height of which is more than 25 m. The mountains are covered with dense natural forests and several springs. The resort lies at a distance of around 40 miles from Zakho District in Duhok, Near the resort, there is a large and wide cavern which takes around half an hour on foot to reach. The cavern has an outlet in the form of a rock arcade of almost a circular shape which was formed across various geological times. In the middle of the cavern, there is a natural spring from which cold and fresh water flows on an ongoing basis and throughout the year.

<u>Sarsang</u>: After departing from Swarah Toka, the highway heads towards the east up to Bamarni, few kilometers away, and then to Skrien which is famous for its vineyards. At a distance from that lies Sarsang (126 kilometers from Mosul) which is one of the most attractive summer resorts in Iraq.

Sarsang resort rises around 1046m above sea level where the temperature does not exceed 34 Celsius degrees. Sarsang enjoys a beautiful climate where cold water flows from the springs through the high mountains, cypress forests, poplar groves, and endless orchards of fruit trees. There are many hotels, chalets, casinos, night clubs in Sarsang in addition to restaurants, markets across the area as well as a summer cinema, theater, popular cafés, shops and all amenities.

Solaf: Rising around 1150m above sea level, Solaf resort is located in a beautiful valley amid the mountains of Amadiyah. "Solaf" means waterfall in the Kurdish language, where water flows from the high mountains in the form of magnificent waterfalls, one of which is 30m high which makes one amazed with the magic of this place, wonderful landscape and the magnificence of the Creator. Solaf resort is abundant with trees and various fruits, in addition to a large number of caves, the most important of which is the splendid summer cave overshadowed by walnut trees and Safa cave. There are also many private hotels and restaurants.

Aneshki: This resort is located between Al-Qudesh Complex and Sarsang resort at a distance of about 9 km. It is characterized by its favorable location overlooking the plains of Sarsang. It is also characterized by its natural landscape, orchards, cold weather,

marvelous cave and famous waterfall where water flows through the casinos, restaurants, and private kiosks located near the waterfall. The recreation ground, casino and al-Kahf restaurant are the most famous places which are usually packed with tourists in the summer.

Kashani: One of the mountain resorts in the district of Zakho, distinctively located at Mount Kashan in the eastern part of mountain Sharansh. Its waters originate from the natural springs flowing from the area of (Haft Tanin). It runs through the rugged mountainous area of charming landscapes abundant with deep valleys and difficult mountainous highlands. Its water is used in agriculture, especially for fruit trees such as orchards of apples, peaches, pears, pomegranates, apricots. The area is famous for osier trees in addition to the different kinds of grapes, walnuts, and almonds.

Ashawa: The name of Ashawa (literally Ashi-Aou) means a water mill as water mills in the area used to be set up in front of the watershed and waterfalls for operation purposes. Ashawa is a resort famous for its high waterfalls with profusion of water and tall beautiful trees. These waters pool together from dozens of springs which combine to form the famous waterfall. The sight of waterfalls is extremely wonderful as if these are rocks carved by the hands of a skilful artist. The truth is that

Ashawa resort is characterized by its geomorphic nature where rocks erode by time affected by the flowing water forming a number of magnificent caves as well as forests of green plums and oak trees which contribute to softening the weather of the area and serve as a landmark for the area as these trees grow only in cold regions of freshwater which makes it one of the most fascinating areas that attract tourists to enjoy the beautiful scenery.



2- Sulaymaniah Governorate

Sarchinar: At about 5 km from Sulaymaniah, Sarchinar resort is located amidst a forest of tall trees and watersheds on a brunette land that reveals the cover on tens of thousands of olive, fig and pomegranates trees which look like a mosaic combining all colors making up a beautiful view unparalleled in any similar city in the east. In the resort, you can find many tourist houses, hotels and cafés.

**Dokan Lake:** the most beautiful resort

in Kurdistan and the most attractive to tourists. It is famous for its dark blue color overlooking the green hills and pine trees.

<u>Derbandikhan Lake:</u> one of the lakes in Sulaymaniyah and is an excellent place for boating sports and all tourism activities.




Ahmed Awa: It is one of the most marvelous mountain summer resorts that can be reached through a paved road 75 km from Sulaymaniah.

#### 3- Erbil Governorate

Salah al-Din: It was built on Birmam Mountain overlooking a plain that extends up to Erbil on one side and Mount Sefin on the other. It is located at about 32 km from Erbil. It rises 1090m above sea level where the temperature does not exceed 36 Celsius degrees. It is one of the most beautiful sites in Iraq, surrounded by cypress and oak trees.

Gali Ali Beg Waterfall: It is one of the most beautiful waterfalls in Iraq. This waterfall is 130 kilometers from the Governorate of Erbil in northern Iraq. It is characterized by its high mountains and opulent water flowing from the peaks of mountains. It was named as such after the Yezidi leader Ali Beg in

his battle against the Kurds.

Bekhal Waterfalls: Ten kilometers after the city of Rawanduz, the visitor hears the roar of water cascading down from the mountain tops on a cold green area surrounded by trees everywhere.

Derbendi Rayat: It is located at a distance of 50km from Gali Ali Beg where the most beautiful snow-covered mountains in Iraq exist. Modern hotels

were built in the area in addition to other tourist facilities.

Haj Omran: Haj Omran resort is located on the eastern northern border and to the east of Mount Hasarost at a distance of 69 kilometers from the Gali Falls. It rises about 1780m above sea level where temperatures drop at night to chilliness whereas the weather is beautiful during the day at a temperature that does not exceed 28 ° C.
