

Testament

From here, I announce to all the Kurds around the world and also to all the people of the world that:

All my research and historical articles and all texts translated from Sumerian and Akkadian ancient works, which have been done and will do with my great pain and effort and have been published and will publish by Qelam and Kurdipedia websites and another ways of publishing, in terms of possession and benefit of material and intellectual rights and how to use them in terms of possession and benefit of material and intellectual rights and how to use them, these rights belong to me and my legal heirs.

My legal heirs include: (Mother) and second-degree(Brother and Sisters) relatives and their first-degree heirs(Children). Also, Mr. Farrokh Nematpour and Mr. Hawre Bakhawan are my legal representatives and trustees in matters related to pursuing the legal rights of my heirs regarding the works published on their websites.

All matters related to my material and spiritual assets are supervised by the supervisor of my financial affairs in the Drammen State office of Ms. Anja and Ms.Setyne.

I declare here that no real or legal person from different governments in Iran, and Iranian non-Kurdish persons have the right to interfere and take

possession of my written works under the title of Iranian culture and history and will not have.

Also, no Kurd in the world has the right to attribute my works to non-Kurdish cultures because we know Kurds who attribute Kurds to Iranian ethnicities and so on. This is false because Kurd-Kurdistan identity is an independent historical, cultural, and sociological identity, and forced political mixing or individual kinship with others does not distort this historical-cultural independent identity.

What I have written is to serve the historical-geographic land of Kurdistan as well as all the Kurds of the world, both those who live in Great Kurdistan and those who live in different countries of the world.

Regarding thefts related to scientific, historical, literary, and cultural works, as well as thefts involving my movable and immovable property, the Norwegian government is my legal representatives to defend my material and moral rights and my heirs and claim the damages.

The possibility of the entry of other sides and legal representatives that I will appoint is not ruled out because my writings and works are not written only for my own interests, but they are written in the way of the rights of Kurds in Iran, Turkey, Iraq, Syria and other Kurds in the world, because this right has been taken away from them and the usurpers of their rights are trying to confiscate their historical and ancient works in order to continue oppression and systematic discrimination to drive them from their ancestral land... because Kurdistan in the heart of the Middle East has abundant water resources and Mines and agricultural lands.

The cultural, historical, ancient, linguistic, and identity interests of Kurds are not common property with others. Therefore, the material and spiritual

interests and the preservation of the rights of the people and the geography of Kurdistan are inseparable, and the political citizenship of different parts of Kurdistan in the countries of Iran, Turkey, Iraq, and Syria does not create any right for the governments of this country to consider my written works as their own. As I said, these works and their rights belong to my heirs and the Kurds of the world.

In the future, the legal formalities of this will be done in the Norwegian court and now this text is published for public knowledge in Kurdipedia and Qelam.

If my death happens earlier than the registration of this will in the court, Mr. Farrokh Nematpour is obliged to inform about this issue with the Norwegian government office in Drammen so that my financial affairs manager Ms. Anja can arrange its implementation. Copies of this will are sent to my legal representatives in Norway and the Netherlands. A copy of it will be also available to the public.
