- ➤ I worked as the lawyer in Baghdad for 13 years, from 1991 until 2004.

- ➤ Upon the establishment of the Iraqi High Criminal Court and their need for judges and prosecutors and felt this important national judicial and participated in two courses of judicial training in UK and Italy, and attended in so many lectures about international criminal laws.

- After being retired he promised and he worked as the volunteer for the Anfal victims, Kurdish faily, Halabjah, Barzanin family, and some other people, he worked actively in the genocide against humanity without any help from governmental or politician.

He joint some meetings, congress, and seminars in inside and outside of Iraq, participated in most of the organization congresses and international parliament, he met in charge of United Kingdom parliament, United Nation in Swis and European Union parliament and some other countries such as France, Holland, Sweden, Austria, Finland, Belgium, Australia, UK and USA.
